Hold Harmless and Indemnity

Company shall defend, indemnify and hold RAAA free and harmless from and against any and all claims arising from Company's actions under this Agreement, including but not limited to, Company's set up and operation of trade show booth, and shall further defend, indemnify and hold RAAA free and harmless from and against any and all claims arising from any act or negligence of the Company, or any officer, agent, or employee of Company, and from and against all costs, attorney fees, expenses and liabilities incurred as a consequence of such claims.

Entire Agreement

This Agreement constitutes the sole and only agreement of the parties hereto and supersedes any prior understanding or written or oral agreements between the parties respecting the subject matter of this Agreement.

Counterparts

This Agreement may be executed by the parties in one or more counterparts, all of which taken together shall constitute one instrument. Facsimiles or electronic scans of original signatures shall be binding upon all parties.

Choice of Law and Venue

The laws of the State of Colorado shall govern the construction and enforcement of this Agreement and any suit which may arise based on this Agreement, whether at law or in equity, without giving effect to any conflicts of laws principles there- of. The parties agree that any lawsuit that may arise pursuant to this Agreement shall be brought only in the State District Courts of Adams County, Colorado.
